

**RESOLUTION NO. 1473**

**A RESOLUTION AMENDING RESOLUTION NO. 881, ARTICLE III, SECTION 3, RATE STRUCTURES, WHICH IMPOSED FEES AND CHARGES FOR STREET LIGHTING SERVICES FOR EACH STREET LIGHTING TYPE; TO INCREASE FEES BY TWELVE PERCENT (12%) EFFECTIVE JULY 1, 1998.**

WHEREAS, Wilsonville City Code Section 3.200 Street Lighting Types states the overall policy governing street lighting fees in the City; and

WHEREAS, on November 18, 1991, City Council adopted Resolution No. 881 which revised street lighting fees and established the methodology, fees and use of dwelling unit factor (D.U.F.); and,

WHEREAS, with the D.U.F. each residential customer was charged based on one (1) D.U.F.; multi-family was based on the number of living units in the complex; and commercial and industrial was based on one employee equivalent to one D.U.F.; and

WHEREAS, the costs of providing street lighting services have increased faster than the increase in revenues; and

WHEREAS, on May 12, 1998, the Budget Committee recommended an increase in street lighting fees and charges of twelve percent (12%) effective July 1, 1998.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. Rates for each street lighting type based on a dwelling unit factor shall be increased by twelve percent (12%).


2. Rate structures shall be as follows:

Street Lighting Type	Lighting District	Monthly D.U.F. Rate
Type 1: Cobra Head	Arterial & Collector Streets	\$1.04
Type 2: Acorn	Meadows	\$5.01
Type 3: Town and Country	Fox Chase, Courtside, Day Dream, etc.	\$2.89
Type 4: Mast Arm & Head	Old Town	\$0.80
Type 5: Shoe Box	Charbonneau	\$3.15


3. The billing for street lighting charges shall be monthly or bi-monthly (every other month) as determined by City Council direction.

4. By adoption of this Resolution the costs shown in Article III, Section 3 of Resolution No. 881 for monthly D.U.F. rates shall be amended to reflect the above adopted increase; however, the methodology remains in effect.
